From the President's Perspective:

Not all Safety Professionals have a significant role in employer Drug and Alcohol Testing (DAT) programs, but most have some role, it is a relevant topic that all Safety Professionals need to have some knowledge of for career development. We will be pursuing a speaker on this topic for the next Chapter Year, so if anyone has any suggestions or contacts we could leverage, please let us know!

Regarding the NY HERO act; until we see some NYS Guidance (probably not until after the July 4 Holiday); any planning on that topic will need to be delayed. However, I have some experience with Safety Committees and formation. If anyone thinks that would be a good topic, let us know. I will be happy to oblige. (There's 2 of 4 technical meetings! Yes, I have other ideas as well! I also know someone may have some better ones!)

Regarding return to in-person meetings; currently, it looks like it is possible.
