# Niagara Frontier Chapter

A quick note regarding our chapter finances and meeting fees. Of the National ASSP membership dues you pay, The Niagara Frontier Chapter is given for each member \$15/head of these annual dues. The NFASSP Chapter is part of Region VIII of the ASSP. Region VIII takes \$5 of the \$15 from each members dues given to our chapter for the Regional Treasury, so we end up with \$10 per member per year. In August each chapter in the region had the opportunity to vote on the regional officer's proposals on how to spend some of the money in the regional treasury. All the proposals passed. The funding went mostly to encourage college age student participation in ASSP Student Sections, with some going to regional operating expenses. A few chapters without Student Sections got the Regional VP to agree to give some funds on request to provide a shirt or some type of ASSP branded material to any students that decide to join our chapter. So, if you know of any interested college students encourage them. If you'd like, let me know and we can send them an invitation to join also.

Getting back to the Chapters Treasury – it has suffered over the past two years as we tried to reign in expenses (which include website hosting fees, SPY Awards, etc.) with the absence of meeting income. In years gone by, we charged \$20/head on plated meals where we made about \$2/head. In the past, we also had somewhere around 35-50 members per meeting. So, we made about \$70 – 100 per meeting that went directly to the Treasury. Today, to try and keep the cost of the meal down, we have a meal of pizza, wings and salad or subs and wraps (which is much easier to coordinate); and the chapter makes much less income per meeting. We greatly appreciate JW Danforth's generosity in letting us use their Training Center which reduces room rental fees. Overall, when our income is down, it impacts what the Niagara Frontier Chapter can do in terms of delivering member value. We would like to do things like sponsor a 1or 2 day Professional Development Conference or be a co-sponsor of a presenter on a current topic of Safety/Risk Management. So - please remember if you make a reservation, order food and don't show, it impacts what we can do as we lose not only the minor profit we make, but the expense of the food as well.
